- (a) The members of the Club shall so exercise their rights, powers and duties and shall, where appropriate, use their best endeavours to ensure that others conduct themselves so that the business and affairs of the Club are carried out in accordance with the Rules and Regulations.
- (b) The members of the Club from time to time shall be those persons listed in the register of members (the "Membership Register") which shall be maintained by the Club committee.
- (c) Any person who wishes to be a member must apply on the Membership Application Form and deliver it to the Club. Election to membership shall be at the discretion of the Club Committee and granted in accordance with the anti-discrimination and equality policies. An appeal against refusal may be made to the Club Committee
- (d) In the event of a member's resignation or expulsion, his or her name shall be removed from the Membership Register
- (e) Members who are granted a Mooring or Caravan hardstanding do so with agreeing that they must use the club house and attend SMYC events on a regular basis throughout the year (refer to SMYC rules). Moorings and Caravan hardstanding's are allocated on a yearly basis at the discretion of the SMYC committee who hold the right to terminate membership and withdraw associated Moorings / Caravan hardstanding's with immediate effect if the above terms or club rules are not adhered to in full.
- (f) The members of the club are expected to attend 'Estates' working weekend parties as per the rules. Failure to do so could impact on being offered a Mooring or Caravan hardstanding the following year.
